## **REPORT ON THE BARBADOS GENERAL ELECTION 2022**

### **1. INTRODUCTION**

- 1.1 On Monday December 27, 2021, Writs for an election in the thirty (30) constituencies were issued by the President of Barbados, to the thirty (30) Returning Officers listed in Appendix A, who were appointed under Section 31 of the Representation of The People Act, Cap 12 (hereinafter referred to as the “Act”).
- 1.2 The Writs, issued in accordance with Section 36(1) of the Act, appointed:-  
Monday January 3, 2022 as Nomination Day,  
Wednesday January 19, 2022 as Polling Day and  
Thursday January 20, 2022 as the latest day for return of the Writs.
- 1.3 In accordance with Section 18 (1) (a) of the Act, on Monday December 27, 2021, the President issued a Proclamation declaring the period ending nineteen days after the issuing of the writs, which was Saturday January 15, 2022, as the Special Electoral Registration Period. Also on Monday December 27, 2021, the President by Order, appointed Wednesday January 12, 2022 as:
  1. The Polling Day for Foreign Service Electors at Missions, in accordance with Rule 44 (1); and
  2. The Special Polling Day for Election Officers, in accordance with Rule 30 (2A).
- 1.4 In accordance with Regulation 35(1) of the Representation of the People (Registration of Electors) Regulations, 1990, the Chairman of the Electoral and Boundaries Commission (hereinafter referred to as the Commission) by Order dated Monday December 27, 2021, directed the Chief Registering Officer to establish an Electoral Revising Centre for each constituency with effect from Wednesday December 29, 2021. The Revising Centres remained open for the receipt of Claims until Tuesday January 4, 2022 with the exception of Saturday January 1, 2022 and Sunday January 2, 2022 and until Thursday January 6, 2022 for the receipt of Objections.

**2. REVISED REGISTER OF ELECTORS - PRELIMINARY LIST**

2.1 The Commission published the Preliminary List of Electors on Tuesday December 28, 2021, in accordance with the provisions of Section 18 (1) (b) of the Act.

2.2 The Preliminary List, which comprised two hundred and sixty-four thousand, nine hundred and forty (264,940) electors, was made available to the political parties, independent candidates and to the general public at the Public Library, the Electoral Department and the Revising Centres. From Friday December 31, 2021 to Tuesday January 4, 2022, a notice was placed in the press, the department's website, [www.electoral.barbados.gov.bb](http://www.electoral.barbados.gov.bb) and the Government Information Service's website, <https://gisbarbados.gov.bb>, which invited the public to inspect the Preliminary List to ensure that they were registered. The notice encouraged persons whose names did not appear on the List to register on or before January 4, 2022 the day by which Claims/Applications were to be filed with the Registering Officers at the Revising Centres, in order to be eligible to vote at the election.

**3. ELECTION ADMINISTRATION**

3.1 The General Election of Wednesday January 19, 2022 was conducted by the Commission in accordance with the provisions of the Representation of the People Act and Section 42 (1) of the Constitution of Barbados which provides that "The election of members to the House of Assembly shall be conducted under the direction and supervision of the Commission". The members of the Commission are:-

3.2 In accordance with Section 30 (1) of the Act, The Chief Electoral Officer, Mrs. Angela Taylor, was appointed the Supervisor of Elections and the President, in accordance with Section 30 (2) of the Act, appointed Mr. Ian Browne, the Deputy Supervisor of Elections.

3.3 The January 19, 2022 general election was the first one conducted during the COVID-19 pandemic. As a consequence, the number of election workers deployed was significantly increased by persons providing temperature checks, hand sanitizing and sanitizing of the voting booth and pencils.

3.4 A total of three thousand, eight hundred and seventy-one (3,871) Election Officers were engaged in the conduct of the elections, in the following categories:-

#### 4. THE CANDIDATES

4.1 One hundred and eight (108) persons were duly nominated on Monday January 3, 2022 to contest the thirty (30) seats in the election. There are as listed below:

**5. NOMINATION CENTRES POLLING STATIONS & COUNTING CENTRES**

- 5.1 Thirty (30) Nomination Centres were established; one (1) in each constituency, twenty-seven (27) were housed in government owned facilities and three (3) in privately owned buildings.
- 5.2 On Special Polling Day, eleven (11) polling stations were housed in government owned facilities and nineteen (19) in privately owned.
- 5.3 On Polling Day, the three hundred and thirteen (313) Polling Districts were divided into five hundred and forty-one (541) Polling Divisions which were accommodated in two hundred and sixty-three (263) buildings. Of these, one hundred and twenty-eight (128) were government buildings and one hundred and thirty-five (135) were privately owned properties.
- 5.4 Of the thirty (30) buildings used for the counting of votes, twenty-five (25) were government owned and five (5) were privately owned. A complete list of Polling Stations may be viewed at Appendix C.

**6. POLITICAL BROADCASTS**

- 6.1 Regulations 4 (a) & (b) of the General Elections (Allocation of Broadcasting Time) Regulations 1990 make provision for the allocation of broadcasting time, during an election, to any political party which satisfies the Commission that no less than ten (10) of its members are validly nominated candidates for the election.
- 6.2 The Barbados Labour Party, the Democratic Labour Party, the Alliance Party for Progress and Solutions Barbados, having complied with Regulation 4 and submitted applications for the allocation of broadcasting time, were allocated broadcasting time as follows: -

**Barbados Labour Party**

- (1) One 15-minute broadcast on Tuesday January 11, 2022
- (2) One 15-minute broadcast on Saturday January 15, 2022
- (3) One 30-minute broadcast on Monday January 17, 2022

**The Alliance Party for Progress**

- (1) One 15-minute broadcast on Wednesday January 12, 2022
- (2) One 30-minute broadcast on Sunday January 16, 2022

**The Democratic Labour Party**

- (1) One 15-minute broadcast on Friday January 14, 2022

**Solutions Barbados**

- (1) One 15-minute broadcast on Thursday January 13, 2022

**7. PUBLIC RELATIONS**

- 7.1 As part of the ongoing registration outreach programme for updating the Register of Electors and for election preparation, on Sunday July 18, Sunday September 19 and Sunday November 21, 2021, the Commission, through a Public Notice, used the print and electronic media to provide the public with the criteria for being registered as an elector and invited:
  - (i) all qualified persons eighteen (18) years and over who had not yet applied to be registered as electors or who had not been photographed for a Barbados Identification Card to make the appropriate application;
  - (ii) all registered electors who had a change of address but had not yet notified the Electoral Department to complete the required Change of Residence Form (Form 10) and file it with the Department.
- 7.2 Electors were provided the facility of viewing the polling station at which they are required to vote by logging on to the Department's website [www.electoral.barbados.gov.bb](http://www.electoral.barbados.gov.bb) and querying the chatbot.
- 7.3 Additionally, there was an extensive use of the media over the period Sunday January 16 to Tuesday January 18, 2022 through which the public was informed or reminded:
  - 1. of the several ways to check the status of their registration
  - 2. of the forms of identification which may be presented at the polling station
  - 3. that Identification Cards which have been issued in excess of ten years may be presented at the polling station

- 4. that electors without any form of identification should attend the polling station as they would be permitted to vote
- 5. that electronic devices, smart phones, smart watches, smart pens etc., were prohibited in the polling station
- 6. of the assistance which the Presiding Officers provide to the blind, physically incapacitated, illiterate and mentally challenged electors
- 7. that on polling day, the Electoral Office would function as an Information Centre, assisting registered electors with information on the Polling Station at which they were registered to vote
- 8. of the voting procedure; the marking of the X next to the candidate of choice, folding the ballot to hide the X and showing the Presiding Officer the special stamp before placing the ballot in the ballot box
- 9. of election day offences such as, the sale or exposure of intoxicating liquor, the use of music and paraphernalia, congregating within 100 yards of the polling station and employers to allow employees time to vote.

7.4 Circulars were also sent to all electors informing of Polling District and Polling Station at which they were registered to vote; the circulars were posted over the period January 10 to January 12, 2022, which gave electors adequate time to use any of the available means of checking their registration status.

## 8. **VOTING**

### 8.1 **VOTING BY ELECTION OFFICERS**

- 8.1.1 Wednesday January 12, 2022 was designated Polling Day for the Election workers as well as police and other security officers who would be deployed at various polling stations in the conduct of the poll.
- 8.1.2 Special Presiding Officers were appointed by the Commission to supervise the voting, and polling was conducted between 7.00 a.m. and 5.00 p.m., at the designated polling station in each constituency.
- 8.1.3 Three thousand, six hundred and thirty-one (3,631) Election Workers, police and other security officers were registered to vote on Special Polling Day.

## 8.2 VOTING BY FOREIGN SERVICE ELECTORS

8.2.1 Wednesday January 12, 2022 was also designated as Polling Day for the Foreign Service Electors. The Electoral and Boundaries Commission in accordance with the provisions of Section 13 (1) of the Act, appointed the Heads of the Missions as Presiding Officers at the respective Missions.

8.2.2 Thirty-four (34) Foreign Service Electors were registered to vote on Polling Day.

## 8.3 VOTING BY OTHER ELECTORS

8.3.1 Wednesday January 19, 2022 was designated as Polling Day for all other registered electors and polling was conducted between 6.00 a.m. and 6.00 p.m., at the designated stations in each constituency.

8.3.2 Two hundred and sixty-two thousand, six hundred and seventy-four (262,674) persons were registered to vote on Polling Day.

## 9. REGISTER FOR ELECTIONS

9.1 In accordance with Section 18 (3) of the Act, the Commission published a Register for Elections on Sunday January 16, 2022. It was made available to the political parties and other nominated candidates and was displayed for public inspection at the Public Library and the Electoral Department.

9.2 The total number of registered electors was two hundred and sixty-six thousand, three hundred and thirty-nine (266,339) as follows:

## 10. **COUNTING OF VOTES AND PUBLICATION OF RESULTS**

10.1 Government vehicles with Police escorts were used to transport Special Polling Day ballot boxes to the Counting Centres and Transport Board buses with Police escorts were used to transport Presiding Officers with ballot boxes, other Election Officers and Polling Agents to the Counting Centres.

10.2 During the Count, the Returning Officer in each constituency made periodic reports to the media on the progress of the Count. The result of the Count of each box was also entered into a computer programme, ‘the Election Management System’ (EMS), which was monitored from a command centre in the office.

## 11. **ELECTION EXPENSES**

11.1 In accordance with Section 52 (1) of the Act, all Candidates/Election Agents were required to file a Statement of Election Expenses with the Supervisor of Elections within seven (7) weeks of the declaration of the results of the election.

11.2 Candidates/Election Agents are allowed to incur expenses to a maximum of \$10.00 in respect of each person registered as a voter in their respective constituencies. Appendix “D” shows the amount expended on behalf of each candidate.

11.3 The following three (3) candidates have not submitted their Statement of Election Expenses:

Mr. Charles Worrell - Democratic Labour Party

Mr. Wayne Beckles - Independent

Mr. Brian Talma - Independent
